BACKGROUND TENURE

-  Existing and proposed¹ conservation reserves.
-  Existing and proposed¹ reserves vested for "recreation and enjoyment of the natural environment and the agreement defined in Section 2 of the Alumina Refinery Agreement Act 1961".
-  State forest, timber reserves, miscellaneous reserves, and land held under title by the Executive Director.
-  Informal reserves: includes stream, diverse ecotype, and travel route zones, poorly represented vegetation complexes, remnant Darling Scarp ecosystem, and old-growth forest remaining outside existing and proposed conservation reserves.

¹As proposed in the *Forest Management Plan 2014-2023* and from subsequent land acquisitions, area management plans and government policies.

FAUNA HABITAT ZONES

Indicative fauna habitat zones

-  Inside State Agreement Act mining lease areas.
-  Outside State Agreement Act mining lease areas.

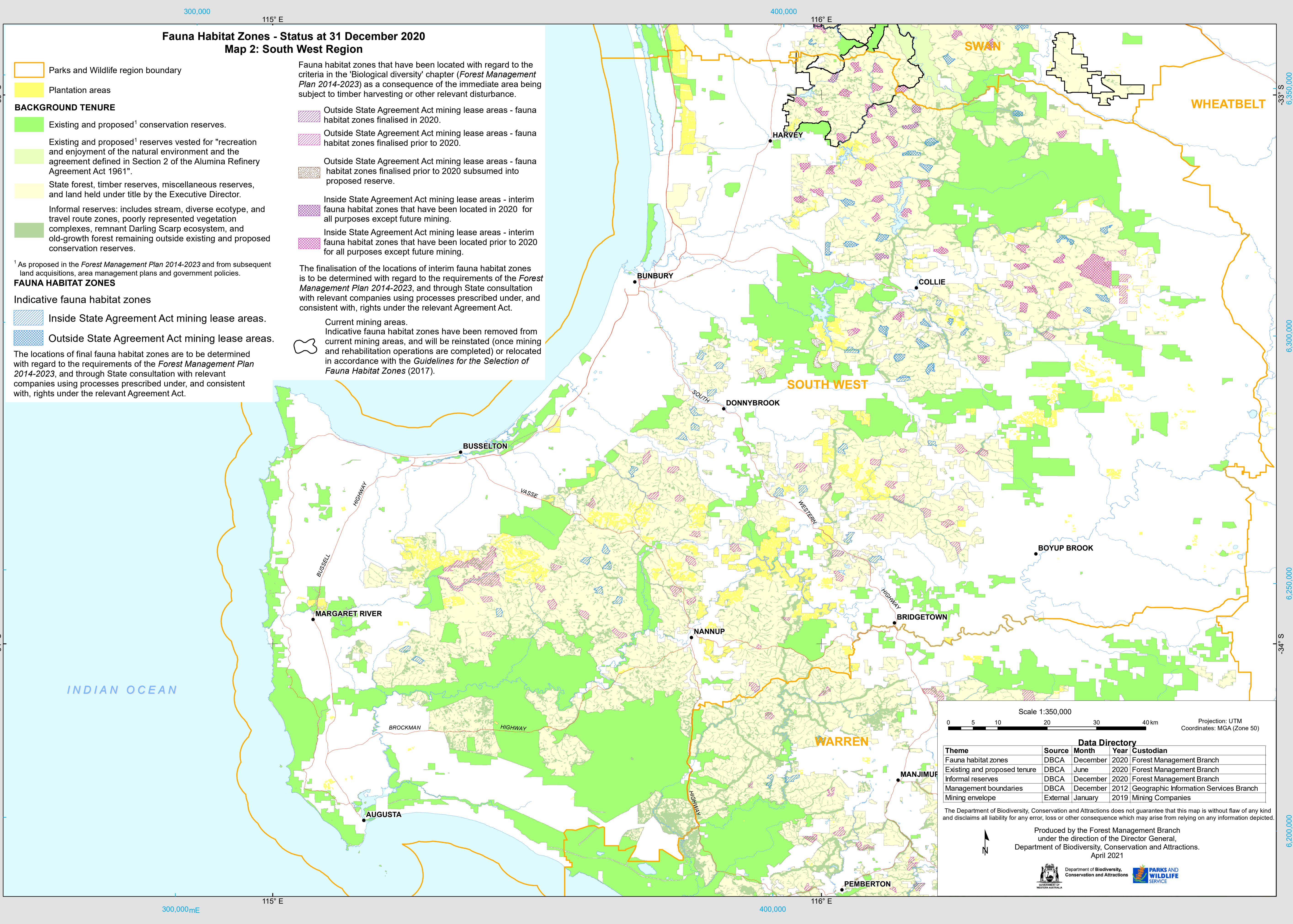
The locations of final fauna habitat zones are to be determined with regard to the requirements of the *Forest Management Plan 2014-2023*, and through State consultation with relevant companies using processes prescribed under, and consistent with, rights under the relevant Agreement Act.

Fauna habitat zones that have been located with regard to the criteria in the 'Biological diversity' chapter (*Forest Management Plan 2014-2023*) as a consequence of the immediate area being subject to timber harvesting or other relevant disturbance.

-  Outside State Agreement Act mining lease areas - fauna habitat zones finalised in 2020.
-  Outside State Agreement Act mining lease areas - fauna habitat zones finalised prior to 2020.
-  Outside State Agreement Act mining lease areas - fauna habitat zones finalised prior to 2020 subsumed into proposed reserve.
-  Inside State Agreement Act mining lease areas - interim fauna habitat zones that have been located in 2020 for all purposes except future mining.
-  Inside State Agreement Act mining lease areas - interim fauna habitat zones that have been located prior to 2020 for all purposes except future mining.

The finalisation of the locations of interim fauna habitat zones is to be determined with regard to the requirements of the *Forest Management Plan 2014-2023*, and through State consultation with relevant companies using processes prescribed under, and consistent with, rights under the relevant Agreement Act.

Current mining areas. Indicative fauna habitat zones have been removed from current mining areas, and will be reinstated (once mining and rehabilitation operations are completed) or relocated in accordance with the *Guidelines for the Selection of Fauna Habitat Zones (2017)*.
