Expression of Interest Form

The artwork will focus on the creation of Djarlgarro, the Canning River, and the significance of water, and will be reproduced in the Djarlgarro (Canning Waterways) Restoration Plan and associated documents. It will include important plants and animals and elements of the landscape, which have been chosen by a committee of Whadjuk Noongar knowledge holders.

Returned EOIs will be assessed by Department of Biodiversity, Conservation and Attractions (DBCA) against selection criteria (included in the Scope) and an artist will be recommended. The EOI from the recommended Artist will be checked and endorsed by the Whadjuk committee.

After a contract/Letter with Conditions is signed, the Artist will meet with the Whadjuk committee to present a proposed design and finalise the design together. The Artist is to produce their completed artwork by 21 October 2024.

It will be photographed/scanned and used in full and repeated in parts throughout the Djarlgarro Restoration Plan and associated documents. The final artwork is likely to be displayed in the DBCA Kensington office.

This EOI process may also be used to select an artist to produce an artwork for DBCA's Swan Canning River Protection Strategy.
